
OFFICE MARKET OVERVIEW


Santa Barbara hosts a cluster of tech, aerospace, healthcare, and defense-related employment, though demand has weakened as companies downsize. Redevelopment projects, like the former Nordstrom on State Street being converted into office space as part of Paseo Nuevo (165KSF), add supply pressure. With no deliveries in 2024 and -50KSF net absorption, the vacancy rate sits at 6.3% and is expected to rise in 2025. Sales volume has remained below \$20M per quarter since 2022, with \$43M transacted across 38 sales in the past 12 months. Average pricing is \$349/SF with a typical size of 4,500 SF and a 4.9% cap rate, aligning with the preferred range for most investors
